## Notice for Expression of Interest (Eoi)

Unnayan Dhara (UD), a reputed NGO, has been working for Sustainable Development of rural poor underprivileged people of Bangladesh through Sustainable Agricultural Development. UD has been implementing a project entitled Promoting Food Security through Sustainable Agriculture (PFSSA) since 2005 in 40 villages of Fulhari, Dudsar, Abaipur, Nittanandapur unions under Shaikupa Upazila of Jhenaidah district with financial support from Bread for the World, Germany. The project has started implementation of its 5<sup>th</sup> Phase since January 2017 in 20 new villages of Hazipur and Hazrapur unions of Magura district along with the previous 40 villages total 60 villages with a target people of 6000 members of around 3000 families where about 50% members are women.
